The Indiana Department of Revenue's (DOR) Motor Carrier Services (MCS) division was provided documentation by the Indiana State Police indicating

(referred to as the "Company") committed oversize/overweight violation(s) of Indiana Code Article 9-20 as noted in the attachment.

The maximum civil penalty amount that may be imposed by Indiana law is \$5,000.00 ("Proposed Assessment"). Copies of citation documentation are enclosed.

If the Company does not pay, negotiate a settlement, or protest the Proposed Assessment within 60 days of this letter, as described below, the Company will receive a demand notice for full payment of the Proposed Assessment. Please note that the Proposed Assessment is in addition to any fines and/or penalties that may have been separately assessed under Indiana law and/or in addition to any fees or fines imposed by a court.

PAYMENT

If the Company does not want to settle or protest the Proposed Assessment, the Company has 60 days from the date of this letter to pay the Proposed Assessment. The Company may pay in the form of a money order, certified check, or company check made payable to the Indiana Department of Revenue.
